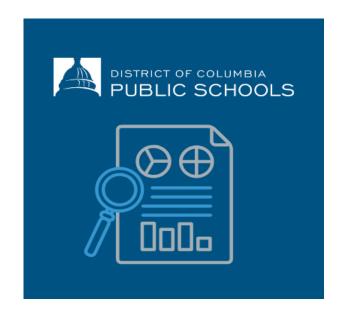

Year-To-Year Budget Notes

Dorothy Height's initial formula allocation is \$8,686,268. This is an increase of \$183,735 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Dorothy Height's projected enrollment was 476. For SY20-21, their projected enrollment is 492, an increase of 16 students. Additionally, due to an increase in the number of English Language Learners (ELL), Dorothy Height is receiving an increased ELL allocation.
