Year-To-Year Budget Notes

H.D. Cooke's initial formula allocation is \$6,859,346. This is an increase of \$784,450 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, H.D. Cooke's projected enrollment was 395. For SY20-21, their projected enrollment is 401, an increase of 6 students. At the same time, due to an increase in the number of students receiving special education services with more intensive needs, H.D. Cooke requires 1 additional self-contained special education classroom, resulting in an increased allocation of staff members and overall special education allocation. Additionally, due to an increase in the number of English Language Learners (ELL), H.D. Cooke is receiving an increased ELL allocation.
