

## Year-To-Year Budget Notes

Enrollment

J.O. Wilson's initial formula allocation is \$7,040,436. This is an increase of \$193,931 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, J.O. Wilson's projected enrollment was 469. For SY20-21, their projected enrollment is 455, a decrease of 14 students. At the same time, due to an increase in the number of students receiving special education services with less intensive needs, J.O. Wilson requires an increase in the number of special education staff members, resulting in an increased overall formula allocation.
