Year-To-Year Budget Notes

King's initial formula allocation is \$5,041,666. This is an increase of \$679,187 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, King's projected enrollment was 279. For SY20-21, their projected enrollment is 307, an increase of 28 students. At the same time, due to an increase in the number of students receiving special education services with more intensive needs, King requires 3 additional self-contained special education classrooms, resulting in an increased allocation of staff members and overall special education allocation. Additionally, for the first time, King is receiving an allocation to participate in the 3rd Grade Health & Physical Education Pool Program with the Department of Parks and Recreation.
