Year-To-Year Budget Notes

Mann's initial formula allocation is \$5,001,521. This is an increase of \$419,571 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Mann's projected enrollment was 407. For SY20-21, their projected enrollment is 456, an increase of 49 students. Additionally, due to an increase in the number of students receiving special education services with less intensive needs, Mann requires an increase in the number of special education staff members, resulting in an increased special education allocation.
