Year-To-Year Budget Notes

Nalle's initial formula allocation is \$5,180,462. This is an increase of \$43,596 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Nalle's projected enrollment was 354. For SY20-21, their projected enrollment is 344, a decrease of 10 students. At the same time, due to an increase in the number of students receiving special education services with less intensive needs, Nalle requires an increase in the number of special education staff members, resulting in an increased special education and overall formula allocation.
