

Enrollment

Peabody's initial formula allocation is \$2,992,899. This is an increase of \$5,716 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Peabody's projected enrollment was 222. For SY20-21, their projected enrollment is 221, a decrease of 1 students. Peabody is not projecting significant changes to the number of students receiving special education or English Language Learner (ELL) services compared to last year.
