

Year-To-Year Budget Notes

Wheatley's initial formula allocation is \$6,472,839. This is an increase of \$455,874 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Wheatley's projected enrollment was 329. For SY20-21, their projected enrollment is 362, an increase of 33 students. Additionally, due to an increase in the number of students receiving special education services with less intensive needs, Wheatley requires an increase in the number of special education staff members, resulting in an increased special education allocation.
