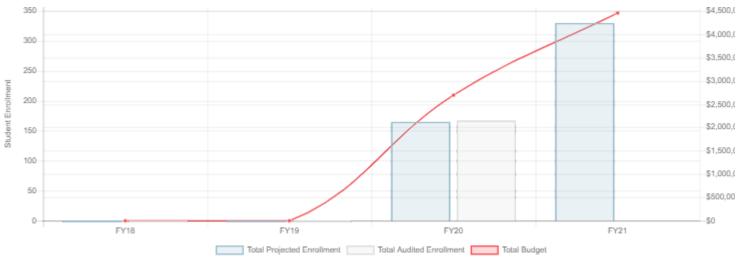

Bard's initial formula allocation was \$3,592,295. After initial allocations were released, Bard requested additional budget assistance funds and received \$862,706. Due to projected revenue decreases for DC, travel funds were reduced across agencies and schools. Therefore, Bard's submitted budget total is \$4,450,000. This is an increase of \$1,761,584 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY20-21, Bard will open their inaugural 10th and 12th grades, completing the school and graduating their first High School cohort. In SY19-20, Bard's projected enrollment was 165. For SY20-21, their projected enrollment is 330, an increase of 165 students. Additionally, due to an increase in the number of students receiving special education services with less intensive needs, Bard requires an increase in special education staff members, resulting in an increased overall special education allocation.
