Year-To-Year Budget Notes

Aiton Elementary School's initial formula allocation is \$4,314,313. This is an increase of \$150,148 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, Aiton's projected enrollment was 222. In SY2021-22, the school's projected enrollment is 226, an increase of four students. Aiton requires one additional general education teacher due to limits on average classroom size. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, the school is receiving 0.5 additional psychologists.

NEW: Aiton will also receive additional stimulus funding in the approximate amount of \$224,993 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
