

## Year-To-Year Budget Notes

**Enrollment** 

Eliot-Hine Middle School's initial formula allocation is \$5,390,651. This is an increase of \$61,327compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, Eliot Hine's projected enrollment was 289. In SY2021-22, the school's projected enrollment is 278, a decrease of 11 students. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, the school is receiving 0.5 additional psychologists and one fewer social worker.

NEW: Eliot-Hine will also receive additional stimulus funding in the approximate amount of \$151,947 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
