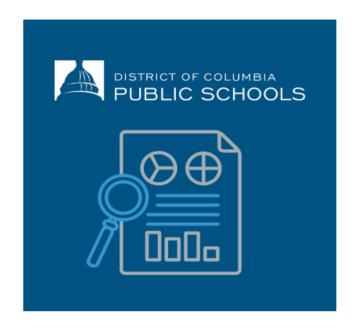

## Year-To-Year Budget Notes

**Enrollment** 

Johnson Middle School's initial formula allocation is \$6,247,992. This is an increase of \$273,311 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, Johnson's projected enrollment was 355. In SY2021-22, the school's projected enrollment is 371, an increase of 16 students. Due to changes in self-contained programming, Johnson will house two additional self-contained special education classrooms, resulting in an increased allocation of staff members. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, the school is receiving one fewer social worker.

NEW: Johnson will also receive additional stimulus funding in the approximate amount of \$260,787 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
