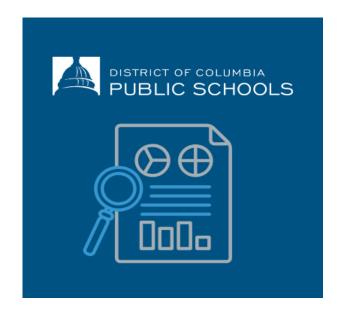

Year-To-Year Budget Notes

Ludlow-Taylor Elementary School's initial formula allocation is \$6,179,447. This is a decrease of \$60,839 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, Ludlow Taylor's projected enrollment was 486. In SY2021-22, the school's projected enrollment is 449, a decrease of 37 students. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, the school is receiving 0.5 fewer social workers. Ludlow-Taylor is receiving one additional general education teacher. In SY2020-21, Ludlow-Taylor received \$140,000 in one-time Chancellor's Initial Budget Assistance, which is not included in the school's initial SY2021-22 budget.

NEW: Ludlow-Taylor will also receive additional stimulus funding in the approximate amount of \$149,579 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
