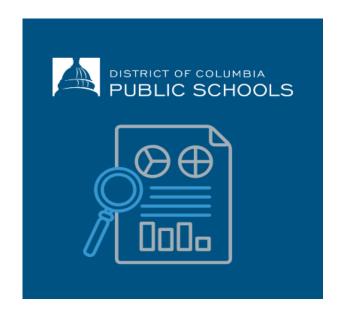

Year-To-Year Budget Notes

McKinley Middle School's initial formula allocation is \$5,118,524. This is an increase of \$475,004 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, McKinley's projected enrollment was 242. In SY2021-22, the school's projected enrollment is 300, an increase of 58 students. As a result, McKinley is receiving 2.5 additional general education teachers. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, the school is receiving one fewer social worker.

NEW: McKinley will also receive additional stimulus funding in the approximate amount of \$167,797 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.

Levels of Flexibility Key
