

Year-To-Year Budget Notes

School-Within-School @ Goding's (SWS) initial formula allocation is \$5,282,554. This is an increase of \$120,636 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, SWS' projected enrollment was 311. In SY2021-22, the school's projected enrollment is 311. Due to changes in self-contained programming, SWS will house one additional self-contained special education classroom, resulting in an increased allocation of staff members. SWS is receiving one fewer general education teacher due to limits on average classroom size. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, the school is receiving 0.5 fewer social workers.

NEW: SWS will also receive additional stimulus funding in the approximate amount of \$57,932 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
