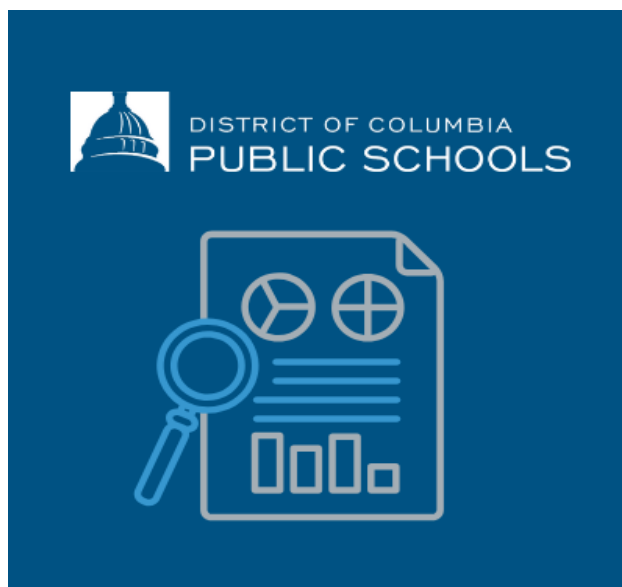

Year-To-Year Budget Notes

School Without Walls @ Francis-Stevens' (SWW-FS) initial formula allocation is \$8,648,792. This is an increase of \$444,803 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, SWW-FS' projected enrollment was 587. In SY2021-22, the school's projected enrollment is 600, an increase of 13 students. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, the school is receiving 0.5 additional psychologists.

NEW: SWW-FS will also receive additional stimulus funding in the approximate amount of \$177,118 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
