Walker-Jones Education Campus's initial formula allocation is \$6,957,806. This is an increase of \$13,667 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, Walker Jones' projected enrollment was 404. In SY2021-22, the school's projected enrollment is 400, a decrease of four students. Walker Jones is receiving 1.3 fewer general education teacher due to limits on average classroom size. Rising position costs contribute to the overall increase in the school's SY2021-22 allocation.

NEW: Walker-Jones will also receive additional stimulus funding in the approximate amount of \$262,079 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
