Year-To-Year Budget Notes

Military Road Elementary School's initial formula allocation is \$2,783,826. This is an increase of \$473,337 compared to the FY22 submitted budget. School budgets are primarily driven by two factors: enrollment and unique student need. In SY21-22, Military Road's projected enrollment was 73. In SY22-23, the school's projected enrollment is 66, a decrease of 7 students. Based upon DCPS' school mental health allocation model, which considers individual student service needs (e.g., special education and 504 service hours), as well as specialized programming, Military Road ES is receiving 1 additional psychologists and 1 additional social workers. Military Road ES is projected to receive 0.64 more ELL teachers due to an increase in the number of English Language Learners, moving from itinerant services to a full time ELL teacher. Military Road received \$2,683 per student eligible for at risk funding, bringing their total At Risk Supplement to \$48,285. This year, security funds are not part of the FY23 school budget allocation and will be managed centrally. Security funding is excluded from both FY22 and FY23 budget totals; thus, this shift does not impact the school's year over year calculation or FY23 allocation.

Levels of Flexibility Key

Level 1 (L1): Required – Locked – These allocations are unable to be changed .

Level 2 (L2): Required – Rarely flexible – Any shift in the allocation will maintain the intended purpose of the original allocation. Principals must demonstrate how they will meet related programmatic requirements.

Level 3 (L3): Flexible – These allocations are provided to schools to budget for staff and programs.
