Year-To-Year Budget Notes

Brookland Middle School's initial formula allocation is \$6,023,760. This is an increase of \$56,725 compared to the FY22 submitted budget. School budgets are primarily driven by two factors: enrollment and unique student need. In SY21-22, Brookland's projected enrollment was 359. In SY22-23, the school's projected enrollment is 329, a decrease of 30 students. Brookland is projected to receive 1 more special educator due to an increase in students with IEPs and/or self-contained classrooms. Brookland is projected to receive 0.5 more ELL teachers due to an increase in the number of English Language Learners. Brookland received \$2,683 per student eligible for at risk funding, bringing their total At Risk Supplement to \$480,168. This year, security funds are not part of the FY23 school budget allocation and will be managed centrally. Security funding is excluded from both FY22 and FY23 budget totals; thus, this shift does not impact the school's year over year calculation or FY23 allocation.

Levels of Flexibility Key

Level 1 (L1): Required - Locked - These allocations are unable to be changed.

Level 2 (L2): Required – Rarely flexible – Any shift in the allocation will maintain the intended purpose of the original allocation. Principals must demonstrate how they will meet related programmatic requirements.

Level 3 (L3): Flexible – These allocations are provided to schools to budget for staff and programs.
