Year-Over-Year Notes

Janney Elementary School's FY23 submitted budget is \$8,131,415. This is an increase of \$290,738 over the FY22 submitted budget. The initial formula allocation includes \$392,034 in Hold Harmless Funds to ensure that Janney ES does not receive less than its submitted budget from last year, and \$290,738 in one-time recovery funds to provide stability during the pandemic. School budgets are primarily driven by two factors: enrollment and unique student need. In SY21-22, Janney's projected enrollment was 718. In SY22-23, the school's projected enrollment is 678, a decrease of 40 students. Janney ES received \$2,683 per student eligible for at risk funding, bringing their total At Risk Supplement to \$37,555. This year, security funds are not part of the FY23 school budget allocation and will be managed centrally. Security funding is excluded from both FY22 and FY23 budget totals; thus, this shift does not impact the school's year-over-year calculation or FY23 allocation.
