Year-Over-Year Notes

Miner Elementary School's FY23 submitted budget is \$7,316,707. This is an increase of \$39,166 over the initial FY23 allocation and an increase of \$316,098 over the FY22 submitted budget. The initial formula allocation includes \$227,132 in Hold Harmless Funds to ensure that Miner ES does not receive less than its submitted budget from last year, and \$276,932 in one-time recovery funds to provide stability during the pandemic. Additionally, during FY23 budget development, Miner ES received \$39,166 in Special Education (SPED) Hold Harmless Funds to account for DCPS's new SPED classroom realignment plan and its impact on the schools' buying power. School budgets are primarily driven by two factors: enrollment and unique student need. In SY21-22, Miner's projected enrollment was 418. In SY22-23, the school's projected enrollment is 395, a decrease of 23 students. Miner ES received \$2,683 per student eligible for at risk funding, bringing their total At Risk Supplement to \$675,991. Miner ES received \$90,000 in ESSER III acceleration funding, that is not included in their budget total. This year, security funds are not part of the FY23 school budget allocation and will be managed centrally. Security funding is excluded from both FY22 and FY23 budget totals; thus, this shift does not impact the school's year-over-year calculation or FY23 allocation.
