Year-over-Year Notes: This submitted budget worksheet reflects how Brightwood Elementary School's principal and school community aligned their FY24 allocation and tailored resources to meet the needs of their student population.

Brightwood Elementary School's FY24 submitted budget is \$11,884,700. This is an increase of \$231 compared to their initial FY24 allocation. During budget development, Brightwood received an additional \$231 due to an agency-wide increase in Title I parental engagement funds. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, Brightwood's projected enrollment was 596. In SY23-24, the school's projected enrollment is 600, an increase of 4 student(s). DCPS is continuing to pass through At-Risk UPSFF dollars to schools. Brightwood Elementary School is receiving \$2,818 per student eligible for UPSFF at-risk funding, bringing their UPSFF At-Risk Supplement to \$704,484. Additional per-pupil at-risk dollars are provided to schools serving higher concentrations of students eligible for at-risk funding. Brightwood Elementary School is receiving \$2,609 in additional at-risk concentration funds.

Security funds will continue to be managed centrally in FY24.
