Year-over-Year Notes: This submitted budget worksheet reflects how Eaton Elementary School's principal and school community aligned their FY24 allocation and tailored resources to meet the needs of their student population.

Eaton Elementary School's FY24 submitted budget is \$5,327,511. This is the same level of funding as the school's initial FY24 allocation. Like the initial allocation, their submitted budget includes \$74,845 in one-time Mayor's Recovery Funds to ensure the school does not receive less than 95% of their submitted budget from last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, Eaton's projected enrollment was 419. In SY23-24, the school's projected enrollment is 427, an increase of 8 student(s). DCPS is continuing to pass through At-Risk UPSFF dollars to schools. Eaton ES is receiving \$2,818 per student eligible for UPSFF at-risk funding, bringing their UPSFF At-Risk Supplement to \$101,446.

Eaton is also receiving \$15,000 in FY24 ESSER III funding. This funding is not included in their budget total because these funds are one-time and supplemental to the school's annual DCPS formula funds. Security funds will continue to be managed centrally in FY24.
