Year-over-Year Notes: This submitted budget worksheet reflects how LaSalle-Backus Elementary School's principal and school community aligned their FY24 allocation and tailored resources to meet the needs of their student population.

LaSalle-Backus Elementary School's FY24 submitted budget is \$6,565,052. This is an increase of \$146 compared to their initial FY24 allocation. Like the initial allocation, their submitted budget includes \$449,728 in one-time Mayor's Recovery Funds to ensure the school does not receive less than 95% of their submitted budget from last year. During budget development, LaSalle-Backus received an additional \$146 due to an agency-wide increase in Title I parental engagement funds. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, LaSalle-Backus's projected enrollment was 267. In SY23-24, the school's projected enrollment is 261, a decrease of 6 student(s). DCPS is continuing to pass through At-Risk UPSFF dollars to schools. LaSalle-Backus ES is receiving \$2,818 per student eligible for UPSFF at-risk funding, bringing their UPSFF At-Risk Supplement to \$402,965. Additional per-pupil at-risk dollars are provided to schools serving higher concentrations of students eligible for at-risk funding. LaSalle-Backus ES is receiving \$13,698 in additional at-risk concentration funds.

LaSalle-Backus is also receiving \$50,000 in FY24 ESSER III funding. This funding is not included in their budget total because these funds are one-time and supplemental to the school's annual DCPS formula funds. Security funds will continue to be managed centrally in FY24.
