Year-over-Year Notes: This submitted budget worksheet reflects how Peabody Elementary School's principal and school community aligned their FY24 allocation and tailored resources to meet the needs of their student population.

Peabody Elementary School's FY24 submitted budget is \$3,115,095. This is an increase of \$22,604 compared to their initial FY24 allocation. During budget development, Peabody ES received \$22,604 in budget assistance for additional resources. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, Peabody's projected enrollment was 210. In SY23-24, the school's projected enrollment is 222, an increase of 12 student(s). DCPS is continuing to pass through At-Risk UPSFF dollars to schools. Peabody ES is receiving \$2,818 per student eligible for UPSFF at-risk funding, bringing their UPSFF At-Risk Supplement to \$67,630.

Peabody is also receiving \$10,000 in FY24 ESSER III funding. This funding is not included in their budget total because these funds are one-time and supplemental to the school's annual DCPS formula funds. Security funds will continue to be managed centrally in FY24.
