**Year-over-Year Notes:** This submitted budget worksheet reflects how Seaton Elementary School's principal and school community aligned their FY24 allocation and tailored resources to meet the needs of their student population.

Seaton Elementary School's FY24 submitted budget is \$7,042,439. This is an increase of \$165,307 compared to their initial FY24 allocation. During budget development, Seaton ES received \$165,162 in budget assistance for additional resources, and received an additional \$145 due to an agency-wide increase in Title I parental engagement funds. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, Seaton's projected enrollment was 345. In SY23-24, the school's projected enrollment is 363, an increase of 18 student(s). DCPS is continuing to pass through At-Risk UPSFF dollars to schools. Seaton ES is receiving \$2,818 per student eligible for UPSFF at-risk funding, bringing their UPSFF At-Risk Supplement to \$391,693.

Seaton is also receiving \$26,000 in FY24 ESSER III funding. This funding is not included in their budget total because these funds are one-time and supplemental to the school's annual DCPS formula funds. Security funds will continue to be managed centrally in FY24.
