Year-over-Year Notes: This submitted budget worksheet reflects how Wheatley Education Campus's principal and school community aligned their FY24 allocation and tailored resources to meet the needs of their student population.

Wheatley Education Campus's FY24 submitted budget is \$7,711,421. This is an increase of \$230,542 compared to their initial FY24 allocation. During budget development, Wheatley EC received \$230,324 in budget assistance for additional resources, and received an additional \$218 due to an agency-wide increase in Title I parental engagement funds. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, Wheatley's projected enrollment was 355. In SY23-24, the school's projected enrollment is 328, a decrease of 27 student(s). DCPS is continuing to pass through At-Risk UPSFF dollars to schools. Wheatley EC is receiving \$2,818 per student eligible for UPSFF at-risk funding, bringing their UPSFF At-Risk Supplement to \$704,484. Additional perpupil at-risk dollars are provided to schools serving higher concentrations of students eligible for at-risk funding. Wheatley EC is receiving \$68,492 in additional at-risk concentration funds.

Wheatley is also receiving \$6,987 in FY24 ESSER III funding. This funding is not included in their budget total because these funds are one-time and supplemental to the school's annual DCPS formula funds. Security funds will continue to be managed centrally in FY24.
